# Supporting diversity and inclusion events

Following completion of their 6 week pathway to employment program successful learners apply for a vacant position with GTS (to evidence the transition from training to employment as well as to provide a fixed point for the completion of suitable screening to BS 7858 which is completed in house)before undertaking a company induction and shift shadowing schedule to ensure they fit in with the remainder of the GTS team. All new starters are allocated a mentor who can assist and guide them through the difficult phase of starting employment, some for the first ever, and the rest in a long time.

## Charitable work and Upskilling of new and existing workforce

the company deliver their own training packages, which include all SIA licence training, and as nearly all employees come through the pathways to security program (mentioned earlier)which consists of a 6 week course that covers basic employment skills, health & safety awareness, first aid, and finally their SIA licence training, GTS can ensure that all employees have been suitably trained in practices that align with their own exacting standards and conform to guidance given in the British Standards. The company deliver a number of other courses which enable persons to complete pathways into alternate lines of employment if they wish
